



PORT ENTRANCE OCCUPATIONAL SAFETY RULES AND INSTRUCTIONS

1- Employees of all organizations operating within the port and truck/trailer drivers entering on a daily basis are required to use Personal Protective Equipment (helmet, reflective vest, steel-toed work shoes). Personnel not using personal protective equipment are prohibited from entering work areas and parking on docks, next to ships, or under cranes.



2- All vehicle drivers within the port must meticulously comply with traffic warning signs and signals.



3- Persons must not allow anyone else to use their own Port Entry Card, nor will they use someone else's Port Entry Card. Otherwise, they are deemed to have accepted all judicial and administrative sanctions.



4- All Occupational Health and Safety rules, all safety rules and warning signs within the facility will be complied with.



5- Private vehicle and truck/trailer drivers must not leave their vehicles for extended periods except for essential purposes such as restroom and mealtimes. They must leave their phone numbers in a clearly visible place on the vehicle where they can be reached if they are unavoidable. Parking vehicles in the work equipment walkway is dangerous and prohibited.

6- Truck drivers will not leave their vehicles or wander around the operation area while waiting to load. Sitting in the direction of traffic on the main road, lighting a stove or gas cylinder, eating, or making tea is dangerous and prohibited.

7- It is dangerous and prohibited for vehicles other than trucks, lorries and heavy equipment to enter loading and unloading areas.

8- While the work machine is running, it is dangerous and prohibited to climb onto the chassis without the operator's knowledge.

9- Bringing, possessing and drinking alcoholic beverages into the port area, walking around and working in the port area while intoxicated is dangerous and prohibited.

10- You may only enter the port area with the permission of the department you are visiting and under the supervision of the responsible personnel appointed by them

11- It is dangerous and prohibited to stand under suspended loads.



12- While you are in the port area, pay attention to pedestrians, forklifts and other moving equipment.



13- Do not approach or touch any machinery, equipment, or stocked products in the port area. Protect yourself from the movements of work machines.



14- Safe walking paths within the port are marked in green. These paths also serve as emergency escape routes. Be sure to check the road when crossing side roads within the facility.

15- When you hear the emergency announcement and/or alarm, leave the dangerous area with port personnel and go to the emergency assembly area. In our facility, the emergency assembly area is the Administration Building Parking Lot.



IN EMERGENCY SITUATIONS, do not panic.

16- The speed limit within the port area is 30 km/h for passenger vehicles, 20 km/h for trucks/trailers, and 10 km/h for construction equipment.
